ON MOTION OF Chelsey Richard Napoleon, Clerk of Civil District Court for the Parish of Orleans, State of Louisiana, appearing herein and on suggesting to the Court, due to the possible dangers associated with the weather advisory currently in place for the Parish of Orleans related to Tropical Storm Zeta; as a result, the possible dangers of extreme weather conditions will create hazardous and unsafe conditions for employees working in the building at 421 Loyola Avenue, New Orleans, Louisiana, and 1340 Poydras Street, New Orleans and the general public conducting business with the Clerk's office on Wednesday, October 28, 2020 and on further suggesting to the court that her office should be closed pursuant to La. R.S. 1:55 so that such closure will be considered a legal holiday so that prescription of all lawsuits being filed with her office will be interrupted on the aforesaid date and on further suggesting to the Court that written approval of the Chief Judge of the Civil District Court was given as required by the statute to authorize such a closure. The office shall re-open on Thursday, October 29, 2020.


