MOTION TO CLOSE THE OFFICE OF THE CLERK OF CIVIL DISTRICT COURT


ON MOTION OF Chelsey Richard Napoleon, Clerk of Civil District Court for the Parish of Orleans, State of Louisiana, appearing herein in proper person and on suggesting to the Court, due to extremely low water pressure in the building which causes a public health safety concern; as a result, the possible dangers will create hazardous and unsafe conditions for employees working in the building at 421 Loyola Avenue, New Orleans, Louisiana, and the general public conducting business with the Clerk's office on Friday, May 14, 2021, at 1:00 p.m. and on further suggesting to the court that her office should be closed pursuant to La. R.S. 1:55 so that such closure will be considered a legal holiday so that prescription of all lawsuits being filed with her office will be interrupted on the aforesaid date and on further suggesting to the Court that written approval of the Chief Judge of the Civil District Court was given as required by the statute to authorize such a closure. The office shall re-open on Monday, May 17, 2021.

IT IS ORDERED that the Clerk of Civil District Court is authorized to close the Clerk of Civil District Court, Civil Division, on Friday, May 14, 2021, at 1:00 p.m. The office shall re-open on Monday, May 17, 2020. Said closure shall have the same force and effect as a legal


